E-SAFETY POLICY

Mission Statement

The teachers and governors of St. Joseph's provide a broad, balanced curriculum to enable each child to achieve the highest standards of education in a Catholic ethos.

THE AIMS OF ST. JOSEPH'S CATHOLIC PRIMARY SCHOOL ARE:

- to nurture the uniqueness of each individual as a member of God's family
- to ensure that the Catholic faith is at the heart of the whole school experience
- to create a well ordered supportive environment in an atmosphere conducive to learning where every child feels confident and safe.
- to create an atmosphere of reconciliation, where pupils can accept the consequences of their own actions, and be encouraged to make more responsible future choices
- to deliver a relevant curriculum with equal access for all pupils
- to encourage and support each child to achieve the highest standards of which they are capable
- to encourage each child to become a concerned compassionate member of society determined to promote justice and peace
- to promote good working relationships based on mutual cooperation and trust
- to provide a welcoming place for parents
- to work in harmony with the parish and the local community.

POLICY STATEMENT

The school will enable all pupils to use Internet technologies for educational purposes. This must be under the supervision of a Teacher, Teaching Assistant or other adult with the approval of the Head Teacher.

AIMS

That our children and staff will be able to:

- Access educational materials and good curriculum practice.
- Have access to information and cultural exchanges between students world wide.
- Have discussions with experts in many fields.
- Communicate with the advisory and support services, professional associations and colleagues.

OBJECTIVES

Internet access will be planned to enrich and extend learning activities. Use of the Internet will be incorporated into each teacher's planning sheets for ICT and cross curricular work. Teachers should check internet resources before using them with pupils.

At Key Stage 1 the majority of access to the Internet will be via teacher or adult demonstration or by searching book marked or hyperlinked sites.

At Key Stage 2, Internet access will be granted to a whole class as part of the school schemes of work, after a suitable education in responsible e-safety.

IMPLEMENTATION STRATEGY

Teaching and Learning

- The school Internet access will be designed expressly for pupil use.
- Pupils will be taught what Internet use is acceptable and what is not and given clear objectives for Internet use.
- The school will ensure that the use of Internet derived materials by staff and pupils complies with copyright law.

Managing Internet Access

- The school Internet access will include filtering to ensure that the material is appropriate to the age of the pupils.
- School ICT systems capacity and security will be reviewed regularly.
- Virus protection will be updated regularly.
- Pupils may only use approved e-mail accounts on the school system.
- Pupils must immediately tell a teacher if they receive offensive e-mail.
- Pupils must not reveal personal details of themselves or others in e-mail communication, or arrange to meet anyone.
- The contact details on the Web site should be the school address, e-mail and telephone number. Staff or pupils' personal information will not be published.
- Written permission from parents or carers will be obtained before photographs of pupils are published on the school Web site.
- Photographs that include pupils will be selected carefully, with parental permission and no names will be published.
- Pupils' full names will not be used anywhere on the Web site or Blog, particularly in association with photographs.
- The school network, through LGFL will block/filter access to social networking sites.
- Newsgroups will be blocked unless a specific use is approved.
- Pupils will be advised never to give out personal details of any kind which may identify them or their location.
- The school will work with the LA, DCSF and the Internet Service Provider to ensure systems to protect pupils are reviewed and improved.
- If staff or pupils discover an unsuitable site, it must be reported to the E-Safety Coordinator.
- IP Videoconferencing should use the educational broadband network to ensure quality of service and security rather than the Internet.
- Videoconferencing will be appropriately supervised for the pupils' age.

- Emerging technologies will be examined for educational benefit and a risk assessment will be carried out before use in school is allowed.
- Personal data will be recorded, processed, transferred and made available according to the Data Protection Act 1998.

Policy Decisions

- All staff must read and sign the 'Acceptable ICT Use Agreement' before using any school ICT resource.
- Students in years 5 and 6 will be asked to sign a pupil version.
- The school will keep a record of all staff and pupils who are granted Internet access. The record will be kept up-to-date, for instance a member of staff may leave or a pupil's access be withdrawn.
- At Key Stage 1, access to the Internet will be by adult demonstration with occasional directly supervised access to specific, approved on-line materials.
- The school will take all reasonable precautions to ensure that users access only appropriate material. However, due to the international scale and linked nature of Internet content, it is not possible to guarantee that unsuitable material will never appear on a school computer. The school cannot accept liability for the material accessed, or any consequences of Internet access.
- The school will audit ICT provision to establish if the e-safety policy is adequate and that its implementation is effective.
- Complaints of Internet misuse will be dealt with by a senior member of staff.
- Any complaint about staff misuse must be referred to the Head Teacher.

Communication Policy

- E-safety rules will be posted in all networked rooms and discussed with the pupils at the start of each year.
- Parents will be asked to sign and return an e-safety form. This will last for the duration of a child's education at St Joseph's.
- Pupils will be informed that network and Internet use will be monitored.
- All staff will be given a copy of the School E-Safety Policy and its importance explained.
- The school E-Safety policy is available from the office on request and on the school website.
